

**SECOND AMENDMENT TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR TO

Second Amendment

This is a *Second Amendment* (*Second Amendment to the Agreement*) to the Agreement for Services of Independent Contractor, by and between the **County of Santa Barbara (COUNTY)** and **eVerge Group, LLC (CONTRACTOR)**.

WHEREAS, on August 22, 2017, COUNTY approved the Agreement for Services of Independent Contractor, number BC#18-109, (Agreement) for the implementation consultation and configurations for the implementation of an Oracle Cloud Services Human Capital Management System (HCM);

WHEREAS, the initial term of the Agreement commenced on August 22, 2017, and was expired on June 30, 2019;

WHEREAS, on April 9, 2019, the COUNTY approved the First Amendment to the Agreement to *increase the compensation, extend the expiration date (First Extension Period) and modify the scope of work* of the existing Agreement;

WHEREAS, the amended term of the Agreement is set to expire on October 1, 2019; and

WHEREAS, the parties now desire to amend the Agreement to *extend the term commencing on August 22, 2017 through February 29, 2020 (Second Extension Period)*.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COUNTY and CONTRACTOR agree as follows.

The Agreement is amended as follows:

1. Section 4, **TERM**, of the Agreement, is amended to state in its entirety:

CONTRACTOR shall commence performance on August 22, 2017, and end performance upon completion, but no later than *February 29, 2020*, unless otherwise directed by COUNTY or unless earlier terminated.

2. Item 1 of Step 2 of Exhibit A, is amended to state in its entirety:

1. Following are the tasks to be completed by CONTRACTOR by ***February 29, 2020*** after completion and acceptance of Step 1:

In all other respects, the Agreement remains unchanged and shall remain in full effect.


