WHEN

Establishing 15 mph School Zone Speed Limits

- State Assembly Bill No. 321
 - Allows a local authority to establish 15 mph speed limits within a school zone
- Criteria
 - Contiguous to school grounds
 - Must qualify as a Residence District
 - Existing posted speed of 30 mph or slower
 - Roadway limited to two vehicular travel lanes
- Implementation
 - In this action, eleven schools were found that meet the criteria which completes the final phase bringing the total number of schools with 15 mph speed zones to fourteen
 - No State Funding Provided
 - Condition Drivers

Randolph Rd: Set 15 mph from San Patricio Dr to 228 feet south of Kellogg Av





El Camino Elementary School



San Simeon Dr: Set 15 mph from 101 feet west of San Julio Av (west) to San Marcos Rd





College School & Santa Ynez Elementary School



Pine St: Set 15 mph from Calzada Av to 96 feet west of Faraday St





Buena Vista Elementary School



Aldebaran Av: Set 15 mph from 85 feet west of Constellation Rd to 110 feet east of El Dorado Rd





Los Berros Elementary School



Via Lato: Set 15 mph from 471 feet south of Calle Seis to 5 feet north of Calle Nueve Calle Seis: Set 15 mph from Via Semi to Via Lato


Via Semi: Set 15 mph from 500 feet south of Calle Seis to Calle Seis

Shaw St: Set 15 mph from 78 feet east of St. Joseph St to 70 feet west of Augusta St

Point Sal Rd: Set 15 mph from 1223 feet west of Ticino St to 120 feet west of Someo St





Arellanes Elementary & Junior High Schools




Sandalwood Dr: Set 15 mph from 20 feet east of Satinwood Rd to 329 feet east of Pinewood Dr





Ralph Dunlap Elementary School



Oak Knoll Rd: Set 15 mph from 67 feet west of Via Nina to 97 feet east of Karnes Rd







The County of Santa Barbara
Department of Public Works
recommends that your Board adopt
an ordinance amending Chapter 23
of the Santa Barbara County Code
thereby establishing the following
School Zone Speed Limits when
children are present:

Aldebaran Avenue	15 MPH
Calle Seis	15 MPH
Oak Knoll Road	15 MPH
Pine Street	15 MPH
Point Sal Road	15 MPH
Randolph Road	15 MPH
San Simeon Drive	15 MPH
Sandalwood Drive	15 MPH
Shaw Street	15 MPH
Via Lato	15 MPH
Via Semi	15 MPH

(speed limits are enforceable 30 days after the second reading approval)
