**WHEREAS**, Streets and Highways Code § 2121 requires the County each year to submit a report to the State of California Department of Transportation showing additions to and exclusions from the County Maintained Road System, specifying the termini and mileage of each route added or excluded from the County Maintained Road System; and

**WHEREAS**, the Board of Supervisors adopted Resolution No. 22-92 on May 3, 2022, certifying the updated County maintained roads with total mileage of 831.21 centerline miles;

**WHEREAS**, Exhibit A sets forth the revisions made to the County Maintained Road System in the past year in accordance with Streets and Highways Code § 2121. Exhibit A also includes the minor corrections made in the measurements of County roads in the past fiscal year.

**NOW THEREFORE BE IT RESOLVED AND ORDERED**, by the Board of Supervisors of the County of Santa Barbara, State of California that:

1. The mileage of County maintained roads, be revised to account for the additions and exclusions specified in Exhibit A attached hereto and incorporated herein by reference; and
2. The total mileage of County Maintained Road System as of May 16, 2023 is 831.61 centerline miles; and
3. The Department of Public Works is hereby directed to submit a copy of this resolution to the State of California Department of Transportation.
