Budget Action: Increase appropriations of \$431,400 in Public Health, Health Care Fund for Salaries and Benefits (\$373,400) and Services and Supplies (\$58,000) funded by

unanticipated revenue from the California Department of Health Care Services (DHCS) through the PATH CITED Round 3 grant funding.

Accepting the PATH CITED funding from DHCS, through an agreement with Cottage Hospital, will increase the Public Health Department's budget by \$1,294,200 over Justification:
