In accordance with Government Code Section 65402(a), the County of Santa Barbara, through the Parks Department, is contemplating the acquisition of two vacant beach parcels for all the uses and purposes of beach access and beach use.

LOCATION: The two parcels (APN: 005-440-002 & 005-440-003) are located on the ocean side of the Union Pacific Railroad Company's right of way in the Santa-Claus Lane area both shown on Exhibit A, attached hereto.

PURPOSE: It is in the public interest and necessity to acquire these parcels to show public ownership on either side of the railroad tracks for the Public Utility Commission to consider the County's permit application for an at grade railroad crossing in the Santa Claus Lane Beach area.

EXTENT: The parcels will be acquired in fee simple interest sufficient to provide ownership title held by the County of Santa Barbara.

In accordance with Government Code Section 65402(a), the General Services Department hereby requests that a finding be made by the Planning Commission as to whether the proposed acquisition is in conformity with the Santa Barbara County General Plan.

In accordance with your findings, please forward the Planning Commission final report to the Office of Real Estate Services, General Services Department for further processing of the proposed acquisition of easements.

The acquisition project is scheduled to be heard by the Board of Supervisors on December 9, 2008. Your earliest submittal to the Planning Commission is appreciated.
