That the Board of Supervisors adopt a resolution establishing "No Parking" zones on Pebble Beach Dr., Palo Alto Dr., Coronado Dr., and Santa Barbara Shores Dr. in the Goleta area

### ALIGNMENT WITH BOARD STRATEGIC PLAN:

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

## **EXECUTIVE SUMMARY & DISCUSSION:**

Ellwood Elementary School requested red curbs be painted south of the crosswalks on Pebble Beach Dr., Palo Alto Dr., Coronado Dr., and Santa Barbara Shores Dr. These residential roads intersect with Hollister Avenue in the Ellwood area. On these streets, cars tend to park immediately in front of the crosswalk. This may make it difficult for vehicles approaching Hollister Avenue to see pedestrians entering those crosswalks. The Public Works Department recommends establishment of no parking zones for the purpose of pedestrian safety at the following locations:

- A. On the east side of Pebble Beach Drive from the centerline of Hollister Avenue to a point 20 feet south of the crosswalk located on Pebble Beach Drive south of Hollister Avenue.
- B. On the east side of Santa Barbara Shores Drive from the centerline of Hollister Avenue to a point 20 feet south of the crosswalk located on Santa Barbara Shores Drive south of Hollister Avenue.
- C. On the east side of Palo Alto Drive from the centerline of Hollister Avenue to a point 20 feet south of the crosswalk located on Palo Alto Drive south of Hollister Avenue.

D. On the east side of Coronado Drive from the centerline of Hollister Avenue to a point 20 feet south of the crosswalk located on Coronado Drive south of Hollister Avenue.

E. On the east side of Cannon Green Drive from the centerline of Hollister Avenue to a point 20 feet south of the crosswalk located on Cannon Green Drive south of Hollister Avenue.

F. On the east side of Lowell Way from the centerline of Hollister Avenue to a point 20 feet south of the crosswalk located on Lowell Way south of Hollister Avenue.
