7 & GOVERNMENT CLAIMS BOARD )

8 WHEREAS, County Board of Supervisors has previously entered into an agreement with the  
9 Victim Compensation and Government Claims Board (hereafter referred to as the "VCGCB") and  
10 desires to continue the program to expeditiously process claims for the unreimbursed losses of victims  
11 of crime and

12 WHEREAS, the Board of Supervisors has designated the District Attorney's Victim Witness  
13 Program a provider of comprehensive services to victims of crime in Santa Barbara County;

14 WHEREAS, the VCGCB has authorized and allocated \$232,064 for the period of July 1, 2011  
15 through June 30, 2012 to implement this project to expeditiously process claims subject to the  
16 execution of a Standard Agreement and acknowledgment of the terms and conditions contained  
17 therein; and

18 WHEREAS, the Santa Barbara County Board of Supervisors has previously entered into an  
19 agreement with the VCGCB and desires to continue the program to continue to establish a Revolving  
20 Fund to assist applicants who have an immediate need for payment of an expense (i.e. funeral/burial,  
21 relocation, and crime scene clean-up expenses), where the applicant would suffer a substantial  
22 financial hardship without such emergency payment, and

23 WHEREAS, the VCGCB has advanced \$50,000 in 2000/2001 as authorized under Government  
24 Code Section 6504 to pay qualifying claims and said program will continue for the period of July 1,  
25 2011 through June 30, 2014. The District Attorney's Office shall exercise appropriate internal records  
26 over the issuance of funds and requests for reimbursement of funds to replenish the account.

27 NOW, THEREFORE, BE IT RESOLVED that the District Attorney of the County of Santa  
28 Barbara is authorized to submit the attached agreements to the VCGCB and is authorized to execute on  
behalf of the Board of Supervisors the Standard Agreement including any extensions or amendments  
thereof.
