That the Board of Supervisors:

- a) Authorize the Director of Public Works to advertise for bids on the Tajiguas Sanitary Landfill Ridgeline Tank Rehabilitation Phase 2 Project (Project No. 828986); and
- b) Determine that the proposed Tajiguas Sanitary Landfill Ridgeline Tank Rehabilitation Phase 2 Project is categorically exempt from the California Environmental Quality Act (CEQA) pursuant to 14 CCR 15301 (Existing Facilities) and approve the filing of the attached Notice of Exemption on that basis.

Summary Text:

This item is on the agenda in order to authorize the Public Works Director to advertise for bids on the Tajiguas Sanitary Landfill Ridgeline Tank Rehabilitation Phase 2 Project (Project No. 828986).

Phase 1 of the Ridgeline Tank Rehabilitation was completed in 2021, and consisted of the removal and replacement of the interior lining system of the 470,000 gallon Ridgeline Tank No. 2. Phase 2 will include removing and replacing the interior and exterior coating of the 225,000 gallon Tank No. 3, and exterior coating of Tank No. 2. This project is required to extend the service life of the tanks. A private contractor; selected through a competitive bidding process, will perform the tank rehabilitation. Final specifications will be brought to your board for approval at a later date along with a construction contract for your authorization. Currently, construction is anticipated to begin in Summer/Fall of 2023.

Background:

The authorization to advertise is an administrative action that is a part of the implementation of the Tajiguas Sanitary Landfill Ridgeline Tank Rehabilitation Phase 2 Project. This project is included in the County of Santa Barbara 2023-2028 Five Year Capital Improvement Plan. The project is exempt from CEQA pursuant to State CEQA Guidelines Section 15301 as it involves the repair and maintenance of existing water storage facilities (above ground tanks) with no proposed expansion in use (Attachment A).
