# **Fourth Amendment to Turner & Townsend Heery, LLC Agreement for Services of Independent Contractor**

## FOURTH Amendment TO AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

**This Amendment No. 4 to Agreement for Services of Independent Contractor (“Amendment”) is entered into by and between the County of Santa Barbara, a political subdivision of the State of California (“County”), and Turner & Townsend Heery, LLC, a Georgia limited liability company (“Contractor”).**

### RECITALS

**WHEREAS**, the parties hereto are parties to that certain **Agreement for Services of Independent Contractor BC21282** dated February 1, 2022, as amended by that certain Amendment No. 1 dated October 18, 2022, and as further amended by Amendment No. 2 dated December 5, 2023 and Amendment No. 3 dated February 6, 2024 **(as amended by Amendment Nos. 1 through 3, the “Agreement”)**; and

**WHEREAS**, the parties hereto desire to amend the Agreement in order to extend the term of the Agreement.

**NOW, THEREFORE, County and CONTRACTOR agree as follows:**

1. Section 4 of the Agreement is hereby amended by replacing Section 4 in its entirety to read as follows:  
  
“The term of this Agreement shall commence on February 1, 2022, and shall terminate on September 30, 2024, unless earlier terminated in accordance with the provisions of this Agreement.”
2. Each of the parties hereto hereby represents and warrants to the other party that:
  - (a) Such party has the full right, power, and authority to enter into this Fourth Amendment and to perform its obligations hereunder and under the Agreement as amended by this Fourth Amendment.
  - (b) The execution of this Fourth Amendment by the individual whose signature is set forth at the end of this Fourth Amendment on behalf of such party, and the delivery of this Fourth Amendment by such party, have been duly authorized by all necessary action on the part of such party.
  - (c) This Fourth Amendment has been executed and delivered by such party and (assuming due authorization, execution, and delivery by the other party hereto) constitutes the legal, valid, and binding obligation of such party, enforceable against such party in accordance with its terms.
3. This Fourth Amendment may be executed in counterparts, each of which shall be deemed to be an original, and all of such counterparts shall together constitute one executed original instrument.




