

**RESOLUTION OF THE BOARD OF SUPERVISORS
COUNTY OF SANTA BARBARA, STATE OF CALIFORNIA**

**IN THE MATTER OF AUTHORIZING THE DIRECTOR)
OF THE PUBLIC HEALTH DEPARTMENT TO EXECUTE)
A PUBLIC BEACH SAFETY GRANT WITH THE STATE) **Resolution No. 20-87**
WATER RESOURCES CONTROL BOARD)**

WHEREAS, the State Water Resources Control Board (State Water Board) has determined that the County of Santa Barbara is eligible to receive funds from the Waste Discharge Permit Fund and the Public Beach Safety Grant Program pursuant to Water Code Section 13260 and Health & Safety Code 115881, respectively; and

WHEREAS, the County of Santa Barbara will use these funds for activities related to the State Water Board's Public Beach Water Safety Program; and

WHEREAS, the State Water Board requires local entities to designate an authority to accept such funding through a Resolution from a Board of Supervisors; and

WHEREAS, this Resolution shall therefore provide evidence that the County of Santa Barbara is authorized to enter into a financial assistance agreement with the State of California and the State Water Board;

NOW THEREFORE BE IT RESOLVED, that the County of Santa Barbara Board of Supervisors hereby authorizes the Director of the Public Health Department to enter into a financial assistance agreement with the State Water Board for the Public Beach Water Safety Program; and

BE IT FURTHER RESOLVED, that the County of Santa Barbara Board of Supervisors hereby authorizes the Director of the Public Health Department to execute Agreement (Number D1914113) in the amount of \$372,675, not to exceed \$124,225 annually, to provide public beach water quality monitoring and public notification services for the period July 1, 2019 through June 30, 2022; and

BE IT FURTHER RESOLVED, that the County of Santa Barbara Board of Supervisors hereby ratifies and authorizes the Director of the Public Health Department to execute future amendments to said Agreement with the State Water Resources Control Board for the Public Beach Water Safety Program, if funding is available and until otherwise ordered by the Board, as long as the award is within 10% of the previous annual amount and there is no significant change in the scope of work required under the agreement; and

BE IT FURTHER RESOLVED, that the County of Santa Barbara Board of Supervisors agrees and further does authorize the Director of the Public Health Department to certify that the County of Santa Barbara has and will comply with all applicable federal and state statutory and regulatory requirements related to the financial assistance funds received by the State Water Board for the Public Beach Water Safety Program.




