PROJECT DESCRIPTION: The contract award is for a previously approved project and all further administrative activities including the statement of final quantities. The existing roadway was damaged during the 2010 declared storm disaster at sites designated 1A02, 1A03 and 1A04. The scope of work covers three retaining walls to repair storm damage that occurred during the winter of 2010. On Gibraltar at MP.5 a 54' by 8' H-pile wall and at MP.2 a 57' by 7' tie-back wall with concrete filled tubular steel pipe and cable tie system anchor system will be constructed. On Tunnel Road a 116' by 7' tie-back wall with concrete filled tubular steel pipe and cable tie system anchor system will be constructed.
