RE: HEARING - Consider recommendations regarding an Ordinance temporarily amending Chapter 28, to add Chapter 28B, Special Encroachment Permits Related to the COVID-19 Pandemic Response, as follows: (EST. TIME: 20 MIN.)

a) Consider the introduction (First Reading) of an Ordinance of the Board of Supervisors of the County of Santa Barbara amending Chapter 28 of the Santa Barbara County Code, to add Chapter 28B, Special Encroachment Permits Related to COVID-19 Pandemic Response, which authorizes the Public Works Director to issue special encroachment permits for operations by businesses and community entities in County roadway rights-of-way until the proclaimed Santa Barbara County Local Emergency based on the COVID-19 virus is terminated or this Ordinance is otherwise earlier terminated;

b) Read the title and waive reading of the Ordinance in full;

c) Set a hearing on the Administrative Agenda for December 8, 2020 to consider the adoption (Second Reading) of an Ordinance Amending Chapter 28, to add Chapter 28B, Special Encroachment Permits Related to COVID-19 Pandemic Response; and

d) Determine that the adoption of this Ordinance is exempt from CEQA pursuant to CEQA Guidelines Section 15301(c).
