**NOW THEREFORE, IT IS HEREBY RESOLVED AND ORDERED,** that Resolution 80-191 and portions of Resolutions 02-317 and 23570 establishing various parking restrictions and a mid-block crosswalk on Foster Road be rescinded at hereinafter locations:

## Crosswalk

500 feet east of the centerline of Dartmouth Lane.

Time Limited Parking Zone (1 Hour Parking, Monday through Friday, 8:00 am to 5:00 pm, except holidays)

• Along both sides of Foster Road from a point 400 feet east of the centerline of Bradley Road to a point 122 feet west of the centerline of Morning Ridge Road.

## Permit Parking Zone

• Along both sides of Foster Road from a point 400 feet east of the centerline of Bradley Road to a point 122 feet west of the centerline of Morning Ridge Road.

## No Parking Zone

• On both sides of Foster Road between the centerline of Bradley Road and a point 400 feet east of the centerline of Bradley Road

**IT IS FURTHER RESOLVED**, that the Santa Barbara County Director of Public Works or designee is hereby authorized and directed to remove appropriate markings and/or signs at said locations as time and resources permit.
