We think that this was a very creative approach towards balanced use and again offers job stability and consistent management for a club that will cater to local families year round.

We have seen the peer-reviewed traffic study showing a reduction in traffic and parking demand based on the owner proposed mitigations included in the Amendment. We love nearby and we would not be in support of anything that further burdened or complicated traffic patterns in this neighborhood. The study is consistent with our own personal experience as neighbors who frequent Channel Drive and Butterfly Beach on a daily basis - mostly on foot and by bicycle.

The appeals simply are not consistent with what we believe to be true about the plans for the club and the needs of the neighborhood. It will create unnecessary delays to the Coral Casino's reopening.

We really urge you to deny this appeal.

If you could see firsthand, what the members meetings are like as people await the club to reopen we feel you would understand where we are coming from. While we are young family, it was heartbreaking to see members who have been relying on the Coral for their daily swim exercise and socialization for decades discussing whether or not they will be able to frequent the Coral again in their lifetime.

They have been pleading with management to do everything they can to create an opportunity for this to happen soon, and we believe that management has responded with a very creative, thoughtful solution as presented in their plan to you.

I had the privilege of enjoying the Coral Casino as a child when my mom and dad joined in the 1960's so she could swim to help with a back injury. I loved it so much that I joined as a member myself as soon as I could. That was back in January 1986.

I have seen quite a few changes over the 50+ years since I first jumped in the pool, not a few of which caused consternation for some. But I must say that, overall, the changes have been quite positive and improved the club — particularly the changes made by Mr. Warner after he acquired the Four Seasons and the club some years ago.

So it won't be a surprise that I'm writing in support of upholding the Montecito Planning Commission's approval of the Coral Casino's Development Plan Amendment.

In particular, I'd like to comment on the opening of Tyde's restaurant to limited use by the public. Over the years, I have used Tydes for family dinners, dinners with guests, and for company events when I was CEO at RightScale. One recurring observation I made is that the restaurant was consistently underutilized. Now of course most of us don't like an overcrowded venue of any sort, but it really served no one to have such low attendance, most especially the members.
