SUBJECT: **Walnut-College Storm Drain Laterals Project (LC8305),
Fourth Supervisorial District**

Recommendation(s):

That the Board of Directors:

- A. Accept the attached Notice of Completion for the College-Walnut Storm Drain Laterals Project and authorize the Clerk to record; and
- B. Adopt the Resolution establishing the final quantities for work performed and materials supplied for the College-Walnut Storm Drain Laterals Project by the contractor R. Baker Inc. (a vendor located at 1101 Pike Lane, Oceano, CA) in the amount of \$498,506.68.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 2. A Safe and Healthy Community in Which to Live, Work, and Visit.

Executive Summary and Discussion:

The project is located on Walnut Avenue between 3rd and A Streets and on College Avenue between A and D Streets in the City of Lompoc. The project consisted of installing storm drainpipes, manholes, and drop inlet structures at both locations. This project will reduce drainage and flooding problems associated with these areas.

This project was a joint project between the City of Lompoc (City) and the Flood Control District. The Joint Powers Agreement (JPA) for the project was approved by the both the City Council and your Board on May 6, 2003 and July 15, 2003 respectively. As identified in the JPA, the District was responsible for the design and construction phases of the project. The City provided certain construction support during construction of the project. The City will also take ownership of the

improvements and will be responsible for maintenance of the facilities.

The District has accepted the work of the contractor R. Baker Inc. completed per plans and specifications. The project was completed at a cost of \$498,506.68.

Mandates and Service Levels:

This project will increase flood protection to the residents in this area.

Fiscal and Facilities Impacts:

This project was included in the Adopted 2003/04 Budget and costs were allocated in the Design Cost Center under the Water Resources Division of the Public Works Department as shown on page D-322 in the budget book. Costs from this project are being paid from Dept: 054, Acct: 8700, Fund: 2470, Program: 3005. This project is also identified in the County's Capital Improvement Plan.
