Adopt the findings in the attached Notice of Exemption that the proposed action is for the establishment of rates for services provided by County Service Area 31, that no expansion of services or facilities will result, and that any increased revenues will be used for meeting operating expenses and financial reserve needs and requirements, and that the action is therefore exempt from the California Environmental Quality Act pursuant to 14 CCR Section 15273. Approve and direct staff to file and post the Notice of Exemption on that basis.

Summary Text:

These actions address setting the benefit assessment rates for streetlighting in the County Service Area 31 (Isla Vista), and North County Lighting District (Los Alamos, Casmalia, Orcutt, unincorporated Lompoc and unincorporated Santa Maria) service areas. There are no changes proposed in the rates from last year.

Background:

County Service Area 31 currently provides for 326 streetlights as well as other services administered by other departments (repair and maintenance of curb, gutters and sidewalks; and the planting and maintenance of streetscape landscaping) in Isla Vista. Revenues are expected to be \$49,293 next year based upon - benefit assessments and property taxes revenues of \$33,573 and \$14,923 and interest of \$797 respectively. Total expenses for next year's services are expected to be \$56,917 with the \$7,624 remainder coming from fund balance. The benefit assessment rate is proposed to remain unchanged for next fiscal year. For street lighting, the current benefit assessment rate is \$12.93 per residential parcel with factored amounts for other development types. The rate was restored in fiscal year 2008-2009 and any additional increase would require an election pursuant to Proposition 218. With the recent changes to the Isla Vista Redevelopment Agency, we anticipate an increase in property tax revenues to CSA 31 in the near future.

North County Lighting District currently provides for 2,812 streetlights in Los Alamos, Casmalia, Orcutt, unincorporated Santa Maria, and unincorporated Lompoc areas. Total expenses for next year's services are expected to be \$414,079 and revenues are expected to be \$402,220 (fund decrease of \$11,859). The benefit assessment rate and special zones of benefit are proposed to remain at \$0.00 per year per parcel at this time in order to reduce the fund balance to an amount of approximately half the annual operating budget. The Department will reevaluate the need to restore assessment annually.

Please see the Engineering Reports in Attachment A, which further describes the streetlighting entities as well as provides fund histories and projections.

Performance Measure:

No changes to the streetlighting level of service provided by County Service Area 31 or the North County Lighting District are currently anticipated or proposed.

Fiscal and Facilities Impacts:

No fiscal changes are proposed to the County Service Area 31, or the North County Lighting District benefit assessment rates. The revenues and streetlighting costs are summarized in the table below.
