Amendment to Cannabis Business License Fee Ordinance

County Executive Office

Overview

- This item proposes changes to the cannabis business license fees:
 - Adjust annual flat fees to reflect time spent on compliance and renewal activities
 - Update fees to include changes in salaries and benefits
 - Adjust department overhead rates as approved by the Auditor Controller
 - Secure cost recovery for 1.5 FTE (one license specialist and 0.5 program manager) in the CEO's Office
 - Withdraw fee recovery measure associated with external data platform which analyzes track and trace system (Metrc)

Background *Licensing Fee*

- Board adopted Ordinance No. 5041, Establishing the Cannabis Business Licensing Fee, in May 2018
- The license fee ordinance has been amended (5) times
- Ordinance was amended in May 2023 to reflect changes in salaries and benefits, update the ICRP for each department, and secure fullcost recovery for (2) cannabis business license specialists
- Proposed amendment will update fees to current staffing and cost levels for licensing

Background *Data Platform*

- In September 2021, the Board executed a Joint Exercise of Powers Agreement with the California Cannabis Authority (CCA) and data analytics platform subscription
- At the July 18, 2023 Board meeting, the Board approved an amendment to include fees for the cannabis licensing program to recover the costs for the use of the platform
- Staff now has access to the State's Metrc data through Metrc Viewer for seed to sale records; platform access is no longer required
- Staff intends to terminate use of the data platform and delete the fee recovery mechanism

Process

- Staff reviewed available data, including historical hours spent on each application by activity and department
- Data was used to update average time spent on each application
- Current hourly rates and indirect costs were applied
- New estimates and rates were reviewed and approved by business license team departments, operational and finance staff
- Full fee study was reviewed and achieved concurrence from the Office of the Auditor-Controller

- Summary
- Existing fee schedule is not achieving full cost recovery because rates are outdated; proposed fees reflect updated business licensing team salaries and ICRP
- Proposed fees are designed to secure full-cost recovery for (1.5 FTE) in CEO's Office for cannabis business license specialist and cannabis program manager assigned to the initial license review, renewals, and compliance
- New fees are estimated to generate ~\$600K in revenues to cover licensing and compliance activities for participating departments

Summary

- Fees include \$10K allocated to the California Cannabis Authority annual membership
- Hourly rates will be reviewed annually and may be adjusted pursuant to changes in the Consumer Price Index (CPI)
- Fee analyses will transition to a 3-year schedule starting in FY 2025-26 to ensure continued program cost recovery
