SUBJECT: Vacation of a portion of Miramar Avenue – Southerly 15' wide portion

adjacent to APN 009-344-007 (56 Miramar Avenue), Montecito; County Project No. 762007 (Real Property Folio # YS 3313), First Supervisorial

Recommendation(s):

That the Board of Supervisors:

1. Adopt the attached <u>Resolution of Order to Vacate</u> a portion of the County's easement interest in the southerly 15' portion of Miramar Avenue (the portion adjacent to APN 009-344-007), which portion of the road right-of-way is no longer needed by the public for road or bike path purposes.

Alignment with Board Strategic Plan:

The recommendations are primarily aligned with Goal No. 1: An Efficient Government Able to Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

The County holds an easement interest in the southerly 15' wide portion of Miramar Avenue adjacent to APN 009-344-007 (56 Miramar Avenue) approximately 1185 square feet in size. This portion of road property is hereinafter referred to as the "COUNTY Property." The Public Works Department has found that the COUNTY Property is not needed by Public Works for present or future use as a road, bike path, or for any other use.

As discussed in the previous Board Letter addressing the Resolution of Intent to Vacate heard by the Board on December 10, 2002, the COUNTY Property is currently an <u>unimproved</u> portion of the Miramar Avenue road right-of-way. The right-of-way road property for Miramar Avenue is 40' in width, however, the paved roadway only covers 10' of the 40'. The road is primarily used as a walkway to provide beach access to pedestrians and is not intended for regular vehicular use. The vacation of the southerly 15' of Miramar Avenue will allow the owner of the adjacent parcel to meet Condition #3 on his permit 00-CDP-231H, which enables him to redevelop the residential unit on his property that burned down a few years ago. The Zoning Administrator has already approved this permit.

On December 10, 2002, the Board of Supervisors adopted Resolution 02-449, a Resolution of Notice of Intent to Vacate a County Road, providing notice to the public that the County intends to dispose of the COUNTY Property (Clerk of the Board File No. 02-01216). The Board of Supervisors also set the date of January 28, 2003, as the hearing date for parties interested in the road vacation to comment on the proposed road vacation.

On Monday, January 13th, and on Monday, January 20th, the Public Works Department is publishing notice of the Board's intention to vacate the subject portion of Miramar Avenue and notice of the January 28th hearing date in the Santa Barbara News-Press pursuant to California Streets and Highways Code Section 8322(a).

The Public Works Department will also post notice of the Board's intention to vacate the subject portion of Miramar Avenue and notice of the January 28th hearing date conspicuously along the subject portion of the road to be vacated for two (2) weeks prior to the January 28th hearing date pursuant to Streets and Highways Code Section 8323.

In the event the Board elects to proceed with the road vacation by adopting the attached Order to Vacate the subject portion of Miramar Avenue, said Order to Vacate will be recorded at the Office of the County Recorder by the Facilities Services Division on behalf of the Public Works Department. Upon recordation of this document, the road vacation will be complete.

CEQA and Government Code Section 65402 Information:

The CEQA review for this road vacation was included in the CEQA document for the redevelopment project as a whole and has been deemed exempt by Planning and Development.

The Planning Commission, in their hearing on November 20, 2002, determined that the road vacation and real property conveyance is in compliance with the County's adopted General Plan pursuant to Government Code Section 65402.

Mandates and Service Levels:

No change in programs or service levels.
