




Context

Tax Collection and Reporting

- Collected \$0.9 M in cannabis gross tax receipts in Q3, for a total of \$3.9 M collected to date
- Collections were less than Q3 last year
- As of Q2, the 24/25 projected tax revenue is \$5.4 M, which is below the adopted budgeted amount of \$6.1 M

Objectives for the Upcoming Quarters

- Propose and implement Ch 50 ordinance amendments
 - New acreage cap reduction for the Carpinteria-Overlay and Unincorporated areas outside the Carpinteria Overlay area
 - Transitioning Sheriff's licensing function to another department
- Monitor and coordinate new odor abatement requirement affidavits, extensions and installation deadlines
- Continue to improve the Business License application process

Recommended Actions

- a) Receive an update on the status of cannabis tax collection, land use permitting, business licensing, and enforcement;
- b)Provide any other direction to staff regarding the County's cannabis program; and
- c) Find that the proposed actions are administrative activities of the County, which will not result in direct or indirect changes to the environment and therefore are not a "project" as defined for the purposes of the California Environmental Quality Act (CEQA) under State CEQA Guidelines Section 15378(b)(5).
