RESOLUTION OF COMMENDATION FOR STACY JANOS UPON HER RETIREMENT FROM THE INFORMATION TECHNOLOGY DEPARTMENT

WHEREAS, Stacy Janos started her career with the County of Santa Barbara in 1988 as a temporary worker in Elections and General Services while attending UCSB and held her first regular position as an Account Clerk III in Social Services in 1992. Stacy returned to General Services in 1994 as an Account Clerk III and in 1996 she was promoted to the role of Departmental Assistant Senior working in Telephone Services. In 2008, Stacy was promoted to EDP Office Automation Coordinator and in 2021 to her current role as EDP Office Automation Coordinator Senior; and

WHEREAS, during her tenure at the County, Stacy was recognized as County Employee of the Month in December 2014 and again in November 2019. She also served as a member of the Information Technology Department Transition Team in 2022 as part of the County's transition to the new Information Technology Department in 2023; and

WHEREAS, in her 30 years in Telephone Services, Stacy saw the County's telephone and voicemail systems through numerous complex upgrades: moving to Digital Remote Units and PBXs and from there upgrading again: adding VoIP Telephones. She helped in virtualizing telephone application servers and implementing voice recognition functionality on the Voicemail System and much more. She contributed to 5-digit calling, easing communication between County employees, and the E911 system, supporting the safety of everyone in the County; and

WHEREAS, Stacy's job knowledge, skills and experience have contributed greatly to the overall professionalism and success of Information Technology and Communications at the County. Stacy also made significant contributions in other areas, from serving as the ITD Marketing Team lead from 2022 to 2025 to working on the EOC Logistics Communications Unit since 2007, and she was a faculty member of the Employees' University from 2000-2007; and

WHEREAS, Stacy is commended for her faithful and devoted services to the County community. Stacy's technical expertise, dedication, professionalism, positive demeanor, and her skilled storytelling will be greatly missed by her many friends and associates throughout the County;
