#### **Recommended Actions:**

- a) Adopt the attached resolution approving the filing of an application for grant funds from the Recreational Trails Program administered by the State Department of Parks and Recreation for funding to design and develop the Franklin Trail in the Carpinteria Area of the 1<sup>st</sup> District; and
- b) Authorize the Director of Parks to act as agent for the County of Santa Barbara to conduct all negotiations, execute and submit all documents including, but not limited to applications, agreements and payment which may be necessary for the completion of the project.

#### **Summary Text:**

This resolution authorizes County Parks to submit an application for funds to the Recreational Trails Program (non-motorized trails) under the federal Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU). The program is administered by the State of California Resources Agency Department of Parks and Recreation.

#### **Background:**

County Parks will request a grant for funding for the final design and development of the Franklin Trail to connect from the City of Carpinteria on County trail easements up to the US Forest Service property, a distance of approximately five miles to the federal land. An additional two miles up through USFS property will connect to East Camino Cielo at the ridge of the Santa Ynez range for of an approximate seven mile trail. This current grant application is only for the five mile County portion of the trail and

County Parks is in discussions with the State administering agency to determine the future funding possibilities to determine if this grant program can be used for trail development on the federal Forest Service property. If the possibility exists, then an additional request for the development of the federal portion of the trail will be made in a separate subsequent funding cycle.

The public trail project is identified in the Parks, Recreation and Trails map (PRT-2) of the Comprehensive Plan. Once the trail is built County Parks, in association with other trail user groups, will provide maintenance services for the trail.

Narrative: No fiscal impacts with this action. No impacts to facilities. This project is identified in the County's approved FY 07-08 Capital Improvement Plan. The grant application request if for \$404, 800 with a local match required of \$55,200 for a project total of \$460,000. If the grant is awarded, a portion of the matching funds for the grant will be available through a previously awarded \$24,000 CREF grant and the remainder would be available from local source contributions such as the Montecito Trails Foundation.
