SUBJECT: No parking zones on Foster Road in the Fourth Supervisorial District.

**RECOMMENDATIONS:**

C.A. Recommendation: \_\_\_\_\_

That the Board of Supervisors rescind Resolution No. 04-089 which established no parking and time limited (20 minute) parking zones on Foster Road, and adopt a resolution establishing updated no parking zones on Foster Road in the Orcutt area.

**ALIGNMENT WITH BOARD STRATEGIC PLAN:**

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure.

**EXECUTIVE SUMMARY & DISCUSSION:**

Foster Road is a collector road in the Orcutt area. Righetti High School is located on the north side of Foster Road west of Bradley Road. The lane configuration of this portion of Foster Road was modified in December 2005, to include left turn pockets in conjunction with Righetti High School's on-site improvements, which included additional on-site parking. With the change of lane configuration, it is necessary to restrict all on-street parking on Foster Road from Bradley Road to the westerly boundary of Righetti High School because there isn't sufficient width to allow it. The Public Works Traffic Section has prepared the attached resolutions to rescind the old resolution and establish new no parking zones at the following locations:

On the north side of Foster Road between the centerline of Bradley Road and a point 341 feet west of the centerline of Woodland Street.

On the south side of Foster Road between the centerline of Bradley Road and a point 172 feet west of the centerline of Woodland Street.
