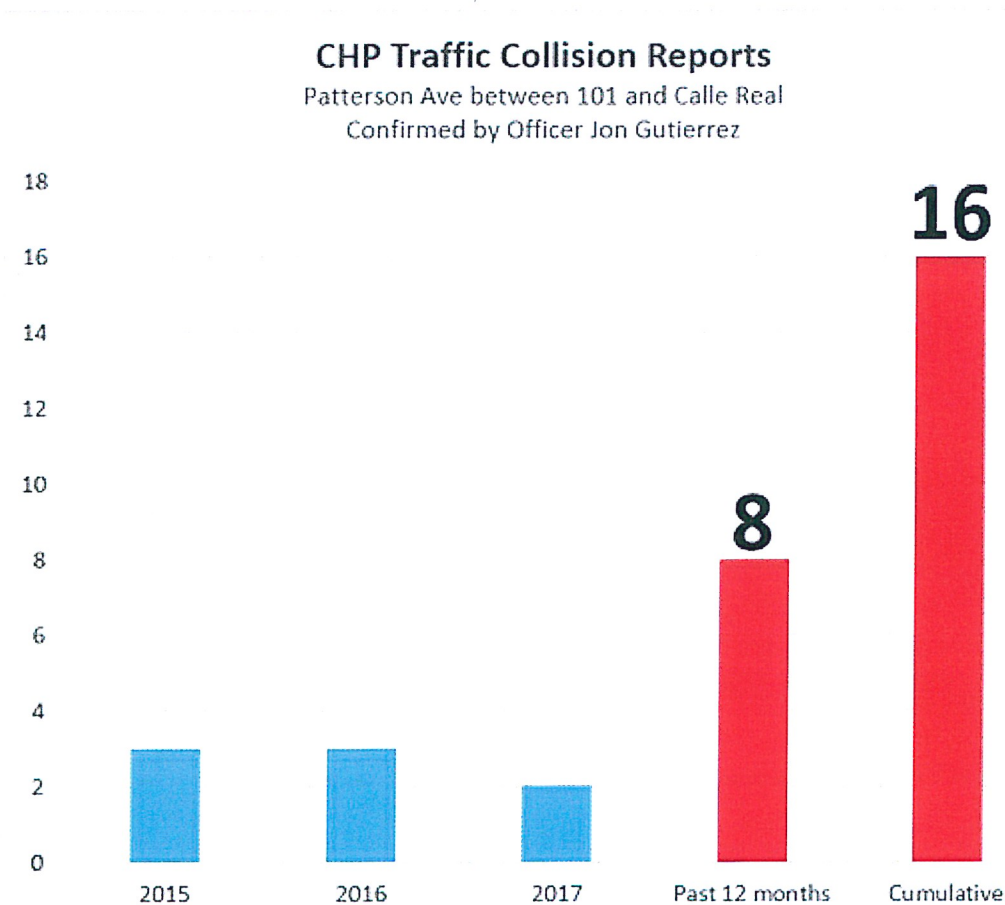
Sean,

Given the anecdotal references from neighbors about collisions along the section of Patterson between 101 and Calle Real, I thought Gary Smart's statement about "only 1 accident in 15 years" seemed out of sync. So I called the Sheriff's Department to confirm one recent collision (July 9) and they stated that the CHP has jurisdiction.

When I called CHP Officer Jon Gutierrez (PIO) he verified that, in fact, there have been 16 collisions in just the past five years (eight of which have happened in the last 12 months). I asked Chris Henson of Supervisor Hart's office to validate this and Chris subsequently confirmed this data with Officer Gutierrez.

Unless there is some context I'm missing, the collision problem is a) significantly worse than has been represented to all prior boards and decision-makers (SBAR, PC, etc), and b) it is getting worse, not better. I've attached my email correspondence with Officer Gutierrez as well as Chris Henson's email. Chris did mention that we was going to touch base with Scott McGolpin on this topic.

The cumulative list of collision dates is (9/28/2015, 10/3/2015, 10/9/2015, 4/26/2016, 10/26/2016, 7/31/2016, 8/4/2017, 8/4/2017, 8/27/2017, 8/29/2018, 9/2/2018, 11/12/2018, 12/9/2018, 12/28/2018, 2/6/2019, 2/16/2019, 7/9/2019) and the graph is as follows:
