Enclosed is a copy of a letter for the Clerk of the Board regarding the ratification of Ordinance No. 2018-01 adopted by the Montecito Fire Protection District ("District") on October 29, 2018. This is the same procedure we followed in 2016 for the District's adoption of "building standards relating to fire and panic safety" that was more stringent than those contained in the 2013 California Building Code and the 2013 California Residential Code.

As you may recall, the County Board of Supervisors' action on the District's ordinance is mandated by Health and Safety Code section 13869.7(c). As we have done previously, I am forwarding our letter to the Board of Supervisors directly to you for processing by the County as appropriate. I hope this meets with your approval.

In addition, following the Board's ratification of the Fire District's ordinance, Section 13869.7(c) requires that the County forward a copy of the District's ordinance to the Department of Housing and Community Development.
