As a customer of the Laguna County Sanitation District and a homeowner in the Tanglewood Development I signed this petition in protest against the proposed increase to my sewer bill. A 3.5% increase is a huge amount for a one year span, as was noted in your flier that the new rate would apply to July 1, 2025 through June 30, 2026.

A new way of calculating the sewage usage for a single family residence needs to be developed. A single family residence no longer consists of two parents and their children. Many of the homes in your district have multiple families living under one roof. This situation creates double if not triple the amount of sewage your plant has to process yet we are all billed the same amount.

Your flier states the rate adjustment is necessary to pay the costs to construct and operate the new facilities. This is for all the new and proposed housing developments in Orcutt. The Tanglewood Development was built is the 1960's and is about one mile away from the sewage plant. We were told in past years the increase was needed to replace antiquated lines and facilities for our development. It is time for new and proposed developments to pay more for the new lines and pump stations needed to get their sewage to your plant.
