SUBJECT: 2002/2003 Measure D Rubberized Asphalt Concrete Overlay in the Santa Ynez Valley Area of the Third Supervisorial District of Santa Barbara County, County Project No. 810487

Recommendation(s):

That the Board of Supervisors:

- A. Approve plans and specifications for 2002/2003 Measure D Rubberized Asphalt Concrete Overlay in the Santa Ynez Valley Area of the Third Supervisorial District of Santa Barbara County, County Project No. 810487;
- B. Award the construction contract in the amount of \$ 992,283.00 to the lowest responsible bidder, A. J. Diani Construction Inc. (Local Vendor) , P. O. Box 636, Santa Maria, California, 93456-0636, subject to the provisions of documents and certification, as set forth in the plans and specifications applicable to the project, as required under California Law;
- C. Authorize chair to execute the construction contract upon return of the Contractor's executed contract documents, and the review and approval of the County Counsel, Auditor Controller and Risk Manager or their authorized representatives;
- D. Approve contingency fund in the amount of \$62,114.15 for 2002/2003 Measure D Rubberized Asphalt Concrete Overlay in the Santa Ynez Valley Area of the Third Supervisorial District of Santa Barbara County, County Project No. 810487.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 1, An Efficient Government Able to Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

On Thursday, May 29, 2003, two (2) bids were opened for 2002/2003 Measure D Rubberized Asphalt Concrete Overlay in the Santa Ynez Valley Area of the Third Supervisorial District in Santa Barbara County. The lowest responsible bid was submitted by A. J. Diani Construction Inc., in the amount of \$992,283.00, which was 2.8% below the Engineer’s Estimate. Public Works staff has reviewed the bid and have found it to be reasonable.

The project consists of placement of rubberized asphalt concrete on the existing roadway. Rubberized asphalt concrete was chosen as the material to be utilized on this project due to greater structural strength and flexibility. Approximately 3.8 lane miles of County maintained roadway will be resurfaced with the construction of this project.



The project was bid in accordance with the Public Contract Code, which requires the Department to award to the lowest responsible bidder.

The specific project locations were approved by your Board in the FY 2002/2003 Road Maintenance Annual Plan (RdMap)

This project was reviewed by the Capital Advisory Committee and Capital Improvement Committee and approved by your Board in the FY 2002/2003 Capital Improvement Plan.

Mandates and Service Levels:

No change in programs or service levels.

Fiscal and Facilities Impacts:

Measure D funding in the amount of \$1,054,397.15 is budgeted in Fund 0015, Program 2900, Org. Unit 0002, Department 054 and Account 7511.
