

**SECOND AMENDMENT  
TO  
AGREEMENT TO PROVIDE PROFESSIONAL SERVICES

THE SANTA BARBARA COUNTY FIRE DEPARTMENT  
And  
CENTRALSPRING TECHNOLOGIES, LLC**

**THIS SECOND AMENDMENT TO FIRE PROTECTION AGREEMENT** (hereafter "AMENDMENT") is made by and between the Santa Barbara County Fire Department (hereafter FIRE), and Centralspoint Technologies, LLC (hereafter Centralspoint) wherein Centralspoint agrees to extend services through June 30, 2026.

**WHEREAS**, Centralspoint agreed in that AGREEMENT TO PROVIDE PROFESSIONAL SERVICES (hereafter "AGREEMENT"); and

**NOW, THEREFORE**, in consideration of the mutual covenants and conditions contained herein, the parties agree to amend that AGREEMENT pursuant to this AMENDMENT as follows:

**EXTEND THE CONTRACT TO JUNE 30,2026:** Garrett Huff, Fire Chief, at phone number (805) 681-5500, is the representative of FIRE and will administer this AGREEMENT for and on behalf of FIRE. Mr. Ron Anderson, Chief Revenue Officer, at phone number (407) 468-9115, is the authorized representative for Centralspoint. Changes in designated representatives shall be made only after advance written notice to the other party.

**CONTINUED FORCE AND EFFECT:** All other Terms of the AGREEMENT not expressly amended by this AMENDMENT shall continue in full force and effect for the Term of such AGREEMENT.

**IN WITNESS WHEREOF**, the parties have executed this AMENDMENT to be effective on the date it is fully executed.


