SUBJECT: Renewal of Eligibility for Federal Surplus Property Program

Fourth Supervisorial District

Recommendation(s):

That the Board of Directors:

- A. Adopt a California Department of General Services resolution authorizing certain departmental representatives to acquire federal surplus equipment for the Laguna County Sanitation District from the State Agency for Surplus Property.
- B. Authorize the Clerk of the Board to execute the resolution placing the Laguna County Sanitation District responsible for compliance with all conditions, terms, reservations, and restrictions associated with the acquisition of such property.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with our organizational values regarding economy in government.

Executive Summary and Discussion:

The Laguna County Sanitation District operates and maintains equipment and facilities for the collection, treatment and disposal of municipal wastewater. From time to time, the District requires new or replacement equipment to effectively perform it functions. The cost of purchasing certain types of equipment can often be minimized by acquiring such equipment that has been deemed as surplus by state and federal agencies.

Subject: Renewal of Eligibility for Surplus Property Program

The Department of General Services disposes of salvage and surplus personal property by making it available to other governmental agencies. In order to research and procure available equipment, each qualifying agency must apply for or periodically renew their approval to participate in the state's surplus personal property program. The District was originally authorized by the Board on November 14, 1995 to participate in this program and last renewed its participation on March 18, 1999. This program has been utilized to procure such items as the mobile reverse osmosis water treatment containers that were retrofitted as part of the TDS Reduction and Recycled Water project.

This action requests board approval to renew the District's eligibility to participate in this program. Eligibility will be subject to renewal every three years.

Mandates and Service Levels:

There are no mandates or changes to service levels with this action.

Fiscal and Facilities Impacts:

Fiscal savings will be realized when purchasing salvaged or surplus equipment at a lower price in comparison with the price of similar new equipment.
