## **AMENDMENT 3 TO THE**

## PHYSICIAN SERVICES PROVIDER AGREEMENT, FEDERALLY QUALIFIED HEALTH CENTER OR RURAL HEALTH CLINIC

This Amendment 3 is entered into by and between County of Santa Barbara, an organization approved by the State Department of Health Services as a Federally Qualified Health Center (FQHC) (hereinafter referred to as County), and the Santa Barbara San Luis Obispo Regional Health Authority (dba CenCal Health), a body corporate and politic (hereinafter referred to as CenCal Health).

## RECITALS:

- A. County and Santa Barbara Regional Health Authority (Authority) entered into a Medi-Cal Physician Services Provider Agreement, Federally Qualified Health Center or Rural Health Clinic ("Agreement") which included any and all of Exhibits A-C, Attachment 1, and the Provider Manual, and Amendment 1 that was effective January 1, 2007, and Amendment 2 that was effective November 1, 2007 that included Exhibit A that was effective January 1, 2008 in Santa Barbara County and March 1, 2008 or after in San Luis Obispo County.
- B. Amendment 2 also included Recitals to change the definition of Authority to mean the Santa Barbara San Luis Obispo Regional health Authority, and to establish the dba of CenCal Health.
- C. The Agreement is effective through December 31, 2008.
- D. County and CenCal Health wish to amend the Agreement to extend the term of the Agreement an additional 3 years.

NOW, THEREFORE, the parties agree as follows:

- 1. The above Recitals are true and correct.
- 2. The Agreement is amended as follows:
  - 9.1 <u>Term.</u> This Agreement shall be effective between Authority and County as of the date it has been executed by both parties, but payments, depending on circumstances, may be made to County for those Covered Services provided to CenCal Health Members prior to that date. The Agreement shall be extended for an additional three (3) years and shall expire on December 31, 2011 unless terminated or amended as hereinafter provided in the Agreement.

Except as amended by this Amendment, the Agreement, as previously amended, will remain in full force and effect.
