RESOLUTION ADOPTING AN ADDITIONAL ONE DOLLAR (\$1.00) FEE FOR RECORDING THE FIRST PAGE OF EVERY INSTRUMENT, PAPER OR NOTICE REQUIRED OR PERMITTED BY LAW TO BE RECORDED FOR IMPLEMENTATION AND ONGOING OPERATION OF A SOCIAL SECURITY TRUNCATION PROGRAM

WHEREAS, the Board of Supervisors supports the implementation of a Social Security Number Truncation Program pursuant to the provision of Assembly Bill 1168, Chapter 627 of the Statutes of 2007 as set forth at Government Code sections 27300 et seq. (section citations are to the Government Code); and

WHEREAS, the County Clerk/Recorder is required to establish a Social Security Number Truncation Program pursuant to section 27301; and

WHEREAS, the Board of Supervisors has been provided the authority to increase recording fees pursuant to section 27361(d)(1); and

WHEREAS, Section 27361(d)(4) requires a Board of Supervisors authorizing a fee under section 27361(d)(1) to require the County Auditor to conduct two reviews to verify that the funds generated by this fee are used only for the purpose of the Social Security Number Truncation Program; and

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the Santa Barbara County Board of Supervisors approves effective May 1, 2008 an additional recording fee of one dollar (\$1.00) for recording the first page of every instrument, paper, or notice required or permitted by law to be recorded to be used solely for the implementation and ongoing operation of a Social Security Number Truncation Program.

BE IT FURTHER RESOLVED AND ORDERED that the fee authorized pursuant to this resolution shall discontinue after December 31, 2017 unless reauthorized by the Board of Supervisors.

BE IT FURTHER RESOLVED AND ORDERED that the Santa Barbara County Board of Supervisors directs the County Auditor-Controller to conduct two reviews to verify that the funds generated by this fee are used only for the purpose of the Social Security Number Truncation Program with in the time frames provided under section 27361(d)(4).
