AMENDMENT TO SUBRECIPIENT AGREEMENT BETWEEN COUNTY OF SANTA BARBARA AND Good Samaritan Shelter

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties hereto agree as follows:

- 1. Section II.A. of the AGREEMENT is hereby amended by replacing Section II.A to read in its entirety as follows:
 - "A. Time of Performance

The term of this Agreement shall begin on August 30, 2023 ("Operating Start Date"), and shall terminate on **December 31, 2024**, unless earlier terminated in accordance with the provisions of this Agreement or there are insufficient ARPA funds available for any reason ("Term"). All Services to be performed hereunder and set out in the Scope of Services may commence on the Operating Start date and shall terminate on **December 31, 2024.** Any funds available but not expended hereunder by **December 31, 2024.** will thereafter no longer be available to the SUBRECIPIENT and shall be returned to the COUNTY."
