Adopt the attached Resolution authorizing the filing of a \$1,377,770 claim with the Santa Barbara County Association of Governments (SBCAG) for an allocation of Transportation Development Act funds for fiscal year 2007/2008.

Summary Text:

The funding the County receives through the Transportation Development Act is, in part, apportioned by your Board (through adoption of this resolution) to Santa Maria, Lompoc and Solvang. These cities in turn use the County's money and their own, to support the activities of Santa Ynez Valley Transit in the Santa Ynez Valley, Santa Maria Area Transit in the Santa Maria Valley and Lompoc Transit in the Lompoc Valley.

The County also directly supports the activities of the Cuyama Transit System (operated by the Cuyama Valley Recreation District) and the Los Alamos Shuttle (operated by the Santa Maria Organization of Transportation Helpers) with TDA monies. Any TDA funds the County receives that are not required to address reasonable transit needs in the unincorporated area can be used for streets and road purposes.

Background:

The Transportation Development Act (TDA) makes funds available to Santa Barbara County for transit, paratransit, transportation planning, pedestrian and bike facilities, and street and road purposes. Each year SBCAG makes an allocation of TDA funding to eligible agencies, and each agency is required to authorize a position to execute and file the claims with SBCAG. The attached resolution designates the Public Works Director as the County's authorized position for this purpose.

Fiscal and Facilities Impacts:

The SBCAG will retain \$49,110 for regional transportation planning, and allocate \$1,202,262 to the County Road Fund 0015/Revenue Account 3092 and \$175,508 to the County Transit Fund 1935/Revenue Account 3092. In addition, the County pays \$1,070,937 to help fund transit in Santa Maria, Lompoc and the Santa Ynez Valley.
