**WHEREAS**, the County of Santa Barbara is currently under a Local and State Emergency Proclamation in connection with the ZACA WILDLAND FIRE, and potential flooding as a result of the fire aftermath which was declared a State Disaster on August 3, 2007; and

**WHEREAS**, the County is eligible for State disaster assistance to respond to the damage caused by the ZACE FIRE. To facilitate the application process for State disaster assistance under the California Disaster Assistance Act, California Governor Office of Emergency Services has requested it is helpful to designate certain County Officials who may apply for such assistance on behalf of the County; and

**WHEREAS**, the California Office of Emergency Services has recommended a universal resolution to be on file for any and all disasters, with updates provided by the County Office of Emergency Services;

**NOW, THEREFORE**, be it resolved that the Board of Supervisors of the County of Santa Barbara hereby authorizes and directs the **County Executive Officer (Michael F. Brown); Deputy County Executive Officer (Ron Cortez); Assistant County Executive Officer/Director of Planning and Development (John Baker); Emergency Operations Chief (Michael D. Harris); Auditor-Controller (Robert W. Geis); Director of Public Works (Scott McGolpin); Deputy Director of Public Works (Tom Fayram); and Disaster Recovery Manager (David H. Rickard)**, currently fill these positions and are to act as representatives of the County of Santa Barbara, and are hereby authorized to execute for and in behalf of the County of Santa Barbara, a public entity established under the laws of the State of California, the applications for assistance and to file them with the Office of Emergency Services for the purpose of obtaining certain state financial assistance under the California Disaster Assistance Act.
