- c.) To Consider and Authorize a Financing Fee of \$5,000.

Summary Text:

The Music Academy of the West is requesting that the County hold a Tax and Equity Fiscal Responsibility Act hearing. They are also requesting the County act as a conduit issuer of tax-exempt Certificates of Participation (COP), in an amount not to exceed \$17 million, for a maximum term of thirty years.

Federal law provides a process for a qualified 501(c)(3) organization to participate in a tax-exempt financing under Section 147(f) of the Internal Revenue Code. The Tax and Equity Fiscal Responsibility Act of 1982 (TEFRA), requires the legislative body of the local agency in which the project will be located to hold the TEFRA hearing in order for the bonds to be tax-exempt.

This item was considered by the Santa Barbara County Debt Advisory Committee on February 23, 2007 and was unanimously approved for recommendation to the County Board of Supervisors.

Background:

The Music Academy of the West (MAW) is a California non-profit public benefit corporation as defined in Section 501(c)(3) of the Internal Revenue Code. It was formed in 1947 to operate a summer music academy and a school for young classical musicians. Its campus facilities were donated in 1951. At that time significant improvements were made to buildings that were constructed in 1909 and 1913.

MAW is requesting that the County hold the required TEFRA public hearing so that tax-exempt Certificates of Participation may be issued on their behalf by Santa Barbara County, as a conduit issuer, in an amount not to exceed \$17 million, for a term of thirty years. The MAW estimates the total project costs will be \$30 million and proposes to utilize its cash reserves to fund half of its cost.

County assistance would take the form of issuing the tax-exempt Certificates of Participation. The proceeds from their sale will be used to finance the projects described below.

The MAW is proposing to use the proceeds from this issuance to finance the construction and other costs associated with a project on their campus in Montecito. Proposed are three phases for the project. Phase I includes improvements to the main recital hall, site improvements (76 new parking spaces, improvements to existing parking, peripheral landscaping to screen certain structures, and improvements of roads and underground utilities), and improvements to two smaller structures (the Rack and Treasure House), where used clothing and household items are sold, and a third structure that is used as a practice studio. Phase II includes improvements to the main house that contains administration, accounting, marketing, conference rooms, a small recital hall, the kitchen, and a dining room. Phase II also includes a two-story addition (basement and first floor) to the main house which will result in five larger practice and rehearsal studios. Phase III includes renovations to two separate practice/rehearsal studios and additional renovations to the Rack and the Treasure House.

The MAW will provide a pledge of its revenues to the Trustee of the COP as security for the issuance. A debt service reserve fund equal to one year's maximum annual debt service is also required to be established and maintained until the final debt service payment is made. No property of the County is in any way subject to any security interest and there is no recourse against the County in the event of a default by the MAW.

The MAW has received a credit assessment of "A-" from Fitch Ratings. The County's Debt Management Policy requires an "A" rating for a conduit financing. Radian Asset Assurance is willing to provide bond insurance to the MAW that would raise the credit rating to "AA". This insurance will be in place if the County agrees to the conduit financing.

The County has participated in a similar hearing and conduit financing on behalf of the Montecito Retirement Association (dba Casa Dorinda).
