**AMENDMENT NO. 1  
TO MEMORANDUM OF UNDERSTANDING  
FOR A PARKING COMPLIANCE PROGRAM IN ISLA VISTA**

This AMENDMENT NO. 1 TO THE MEMORANDUM OF UNDERSTANDING FOR A PARKING COMPLIANCE PROGRAM IN ISLA VISTA (“Amendment No. 1”) dated for reference purposes as of this 9th day of June, 2026, is made and entered into by and between the COUNTY OF SANTA BARBARA (“County”) and the Isla Vista Community Services District’s (“IVCS D,” collectively “Parties”).

**RECITALS**

A. **WHEREAS**, the IVCS D and the County entered into that certain Memorandum of Understanding (the “MOU”) for a Parking Compliance Program in Isla Vista on or about October 14, 2025.

B. **WHEREAS**, the MOU contemplated the IVCS D enforcing parking restrictions on County rights of way within Isla Vista.

C. **WHEREAS**, the IVCS D and the County now desire to revise the MOU to expand the IVCS D’s authority to issue parking citations on County rights of way and identified County owned properties within Isla Vista.

**TERMS**

1. **Recitals:** The recitals set forth above are true and correct and are incorporated herein by this reference.
2. **Contract changes:** The MOU is amended as provided herein (new text is in ***bold italics***, deleted text in ~~strikethrough~~).

A. Section 2 is hereby amended as follows:

“To the extent permitted by law, the IVCS D is delegated authority to enforce existing parking restrictions on County rights of way ***and on the County-owned Properties identified in Exhibit A (the “Properties”), attached hereto and incorporated by reference***, within the community of Isla Vista for a period not to exceed five years, unless terminated earlier upon 30-days written notice by either

party for any reason. The IVCS D's services shall be non-exclusive and shall be in addition to, and shall not replace or supplant, the level of services provided by the County or any other service provider. ~~Ticket pricing,~~ Enforcement procedures, warnings, or and any other operational policies shall be established and may be adjusted at the sole discretion of the IVCS D, subject to applicable law, including the California Vehicle Code and subject to the provisions in this MOU. The IVCS D shall provide the County with a copy of the operational policies implementing the program upon request."

B. Section 4 is hereby amended as follows:

"The IVCS D may not create new parking restrictions and may only enforce those restrictions the County has already enacted or that the County may enact in the future at its sole discretion. *Pursuant to California Vehicle Code Section 40200.5 and other applicable state laws, the County hereby delegates to the IVCS D the authority to issue parking citations on County rights of way and Properties within Isla Vista. The IVCS D shall ensure that all citations comply with state procedural requirements, including citation issuance, notification, and appeals processes as set forth in the Vehicle Code.*"

C. Section 5 is hereby amended as follows:

"The County shall retain any and all authority to exercise its police powers in the County rights of way *and Properties* and the parking enforcement program shall not conflict with any County needs or priorities in the area."

3. **Continuing Effect of MOU.** Except as amended by this Amendment No. 1, all provisions of the MOU shall remain unchanged and in full force and effect. From and after the date of this Amendment No. 1, whenever the term "MOU" appears in the MOU, it shall mean the MOU, as amended by this Amendment No. 1 to the MOU.
4. **Authority.** The persons executing this MOU on behalf of the parties hereto warrant that (i) such party is duly organized and existing, (ii) they are duly authorized to execute and deliver this MOU on behalf of said party, (iii) by so executing this

MOU, such party is formally bound to the provisions of this MOU, and (iv) the entering into this MOU does not violate any provision of any other Agreement to which said party is bound.
