WHEREAS, Section 33490 sets forth a list of requirements for implementation plans; and

WHEREAS, staff of the Santa Barbara County Redevelopment Agency has prepared implementation plan entitled “Five-Year Implementation Plan Update for the Period from 2011 – 2016” (“Implementation Plan”) for the Isla Vista Redevelopment Project Area meeting all of the requirements set forth in Section 22490 of the Law, contained herewith as Exhibit 1; and

WHEREAS, pursuant to Section 33413 of the Law, the Implementation Plan includes a ten-year affordable housing compliance plan; and

WHEREAS, the Isla Vista PAC/GPAC has reviewed the Implementation Plan; and

WHEREAS, adoption of the Implementation Plan is not a project under CEQA as set forth in Section 33490 of the Law and CEQA Guideline Sections 15378(b)(4) and (5).

WHEREAS, the Redevelopment Agency Board of Directors has conducted a duly noticed public hearing on the Implementation Plan.

**NOW, THEREFORE BE IT FOUND AND RESOLVED AS FOLLOWS:**

2. The Implementation Plan meets all of the requirements set forth in Section 33490 of the Law.
