NOTICE IS HEREBY GIVEN that, on November 29, 2022, the Santa Barbara County Board of Supervisors, will conduct the first reading of a draft ordinance amending Chapter 15 of the Santa Barbara County Code. The draft ordinance adopts the 2022 California Fire Code with local amendments. The November 29th meeting will begin at 9 a.m. in the Board Hearing Room, 511 East Lakeside Parkway, Santa Maria, CA. The draft ordinance replaces the 2019 California Fire Code, as the enforcement Code in all areas within the Santa Barbara County Fire Protection District, and all other unincorporated areas of the County where the Santa Barbara County Fire Department, is the authority having jurisdiction. Adoption of the 2022 California Fire Code with amendments, will become the Santa Barbara County Fire Code.
