Background:

On December 5, 2023 the Board of Supervisors adopted the 2023-2031 Housing Element Update. The California Department of Housing and Community Development found the adopted housing element in substantial compliance with State Housing Element Law on January 22, 2024. The next step is for the County to select rezones and County-owned sites to accommodate the RHNA. The Board will consider recommendations the Planning Commission made at hearings on March 27, 2024 and April 1, 2024 regarding which sites to rezone among the sites contemplated in the Housing Element Update.
