SUBJECT: State COPS FY 2004-05 Expenditure Plan

Recommendation(s):

That the Board of Supervisors:

Set a public hearing for November 2, 2004 to hear and consider approval of \$735,026 in resource and use allocation of State COPS funds for supplemental law enforcement equipment, programs and/or personnel in Fiscal Year 2004-2005.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with actions required by law or routine business activity.

Executive Summary and Discussion:

The State Citizen's Option for Public Safety (COPS) Grant for the current budget year has been finalized by the State Department of Finance in accordance with the State Budget as signed by the Governor, with the funds being distributed October 8, 2004. Government Code Sections 30061-30065 outlines the requirements pertaining to the COPS Grant, including that your Board review the expenditure allocation plan in a public hearing to be held each year, separate and apart from the process applicable to proposed allocations of the county general fund. In addition, an annual report on programs funded with the COPS grant is to be filed with the State and the County Board of Supervisors in October of each year. This letter serves to fulfill the requirement for expenditure allocation plan for 2004-2005.

The proposed expenditure plan for fiscal year 2004-2005 also includes the contract cities of Buellton, Carpinteria, and Solvang. The contract cities are procuring formal Minute Orders allowing the Sheriff's Department to administer this grant program on their behalf. The contract city of Goleta administers its own

COPS State Grant and reimburses the Sheriff's department for actual expenditures incurred during the year that are funded with its grant.

The funds allocated to the County of Santa Barbara are to be allocated as follows:

- 5.15% to the County Sheriff for jail construction and operation;
- 5.15% to the District Attorney for criminal prosecution;
- 39.70% to the county and cities within the county (by population); and
- 50.00% to the county juvenile justice plan (sources & uses of which are not included in this letter).

The following is a summary of State COPS allocations and uses for FY 2004-05:

Mandates and Service Levels:

California Government Code Sections 30061 through 30065 contain various requirements for participation in the State COPS grant program, including: the establishment of a Supplemental Law Enforcement Services Fund (SLESF); the establishment and annual meeting of a local oversight committee; guidelines for the Auditor or Treasurer's administration of the monies; providing a minimum of \$100,000 to each city; the formal appropriation of anticipated monies by the Board of Supervisors by public hearing each qualifying year (today's action); the full use or return of funds to the state; and, that the funds may only be used for supplemental front-line law enforcement purposes, including jail construction, District Attorney prosecution and a juvenile justice program.

Funding from the State was reduced in this year compared to 2003-04 for District Attorney (\$549); Sheriff Custody (\$549) and Sheriff Patrol (\$3,793), which will affect program service levels accordingly.

Fiscal and Facilities Impacts:

The amount of State COPS funding was over anticipated in the FY 2004-05 Adopted County Budget in Revenue Line Item Account #4331. The budgeted amount of \$736,000 is \$ 974 over the \$735,026 that will be received. However, corresponding service levels are expected to be reduced accordingly which will result in no County General Fund impact. If the amounts are not expended by the end of the 2004-2005 fiscal year,

these funds must be designated and expended within the time frame allowed by the State, or must be returned to the state.

There are no anticipated facility impacts in continuing this grant program.
