

Dave Davis currently serves as Chairman of the Santa Barbara Metropolitan Transit District Board of Directors, the provider of regional transit services to the Santa Barbara South Coast and a national leader in the electric bus technology. He also is a Water Commissioner for the City of Santa Barbara and member of the Santa Barbara County Air Pollution Control District (APCD) Citizen's Advisory Council. Dave is a member of the board of directors of the Environmental Defense Center, the UCSB Economic Forecast Project, and previously has served on the boards of the Coastal Housing Coalition, the Santa Barbara Downtown Organization, the Santa Barbara Regional Community Economic Project and the Santa Barbara Built Green Advisory Board. He has been a member of the Santa Barbara Regional Chamber of Commerce Business Leadership Council and a trustee of the UCSB Foundation.
