**PROJECT TITLE:** Resolution Authorizing the Director of the Public Works Department to execute the Master Agreement- State Funded Transit Projects with the State of California Department of Transportation-All Supervisorial Districts

**PROJECT DESCRIPTION:** The Public Works Department request the Board of Supervisors to authorize a Resolution authorizing and directing the Director of Public Works to execute Master Agreement No.64A0189 A01, and subsequent Program Supplemental Agreements, Fund Exchange Agreements, and Fund Transfer Agreements with the California Department of Transportation. This Master Agreement allows the County to utilize authorized state funds for transit projects within the jurisdictional boundaries of Santa Barbara County. All state monies allocated under the Master Agreement are disbursed through Program Supplements for State-Funded Transit Projects and any Amendments.



The term project refers to the activity which is being approved and which may be subject to several discretionary approvals by governmental agencies. Further, the Master Agreement will not create any unusual circumstances which would create a possibility that there would be a significant effect. Therefore, the actual Master Agreement is not a project it can be found to be exempt from CEQA.
