WHEREAS, the Emergency Operations Plan serves the County of Santa Barbara, unincorporated areas and communities of Santa Barbara County, and the Santa Barbara County Operational Area, and;

WHEREAS, the Santa Barbara County Office of Emergency Management is the lead agency for emergency management planning for the Operational Area, consisting of the County and all political subdivisions within the county, and;

WHEREAS, the Santa Barbara County Office of Emergency Management has revised the Emergency Operations Plan in accordance with California Government Code Section 8610, et. Seq, and it meets the criteria of the Governor's Office of Emergency Services plan guidance, and;

WHEREAS, the County Departments with responsibilities in the Plan have concurred with the content of the Plan, and;

WHEREAS, Section 12-15 of the County of Santa Barbara Code of Ordinances requires that the Board of Supervisors adopt the Emergency Operations Plan.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of Santa Barbara, acting as the governing body of the County of Santa Barbara, hereby approves and adopts the revised Santa Barbara County and Operational Area Emergency Operations Plan.
