Dear Santa Barbara County Supervisors:

My name is Marcy Winograd and I live in Santa Barbara, where I am a blogger, radio podcaster and organizer of the Central Coast Antiwar Coalition.

I write to make two requests:

- 1) Pass an ordinance prohibiting county law enforcement from facilitating or assisting with immigration raids, abductions and detentions.
- 2) Oppose ALL attempts to renew offshore oil drilling on the Central Coast, where the oil industry has a history of ecological disaster.

We live during perilous times when ICE and its partner agencies are raiding our communities to abduct and disappear people or color, many of whom pick our fruit and vegetables, care for our old and infirm and staff our construction trades. The Trump administration has seized control of our National Guard, deployed the Marines, refused entry to LA-area congress members wishing to access 200 detainees at the Roybal Federal Building in LA and threatened to arrest our Governor. Now is not the time to cooperate with fascism. The city of Glendale awakened to this truth when it announced it would no longer house detainees at the city's police department.

ICE was in Santa Barbara last week, in Oxnard yesterday and in Camarillo this morning, spreading fear throughout immigrant communities. According to 805UndocuFund, an immigrant support organization, ICE will be targeting the Central Coast all this week.

We must be prepared.

Order the [RED CARD](#) (Know your rights) for distribution at county offices and posting of information on the county website.
Bar the police and sheriffs departments and all county agencies from cooperation with ICE, Border Patrol (CPB) and related agencies.

Next, regarding Sable's attempts to restart offshore oil drilling. Let's get creative and think of ways to stop this travesty, this further desecration of our coast, before another oil spill blankets our beaches with black tar, killing marine life and harming our economy.
