Chair Williams and Members of the Board,

I bring you greetings from the nation's oldest and largest civil rights organization, the National Association For the Advancement of Colored People. You know us as the NAACP and our mission is to achieve EQUITY, political rights and social inclusion by advancing policies and practices that expand human and civil rights, eliminate discrimination and accelerate wellbeing, education, and economic security of Black people and all persons of color.

On behalf of the Santa Maria-Lompoc Branch of the NAACP, it's officers and members, we wish to convey our opinion that the Sheriff's policy of cooperating with ICE inflicts "double punishment" for immigrants and it is our belief that all immigrant residents should be **treated the same as all other residents -- no better or worse.** While the safety of the community must be factored in, let be clear that we are not referencing to offenders who have committed and been convicted of violent offenses such as murder, but those who by definition, have **already** been found to be eligible for release from custody by a Judge.

If not because of where they were born, these community members would be allowed to return home to their families and communities. **Subjecting immigrants to additional detention and deportation is double punishment.** When the Sheriff transfers a person to ICE, they either have finished serving time in jail or were in pre-trial custody -- meaning, not convicted of a crime -- and were determined to be safe to be released in the exact same circumstances that a U.S. citizen would be allowed to go home to their loved ones.

There are many counties including Los Angeles, San Mateo, Santa Clara, and Humboldt, that have already ceased transfers to ICE with a bright-line policy of non-cooperation with ICE. Santa Barbara County is behind and you and Sheriff Brown have the opportunity to adopt a policy that ensures we are investing in family unity, not family separation. We must leave this shameful past behind and adopt a humane policy to keep families together.

We implore the Sheriff Department and Sheriff Brown to update their Office policy on ICE transfers and notifications and end this practice.
