Based on a preliminary review of the project the following activity is determined to be exempt from further environmental review requirements of the California Environmental Quality Act (CEQA) of 1970 (Pub. Res. Code Section 21000 et seq.), as defined in the State CEQA Guidelines and County Revised CEQA Guidelines.

<u>PROJECT TITLE:</u> Storm Damage Repairs on Alisal Road about 6.4 miles south of State Highway 246; County Project No. 24STM1-3L10; Third Supervisorial District

<u>PROJECT DESCRIPTION</u>: This item is on the agenda to approve the plans and specifications for the Storm Damage Repairs on Alisal Road Project and to award a construction contract to Seamair Construction, Inc. in the amount of \$360,476.16.

On Thursday July 3, 2025, the County received 15 construction bids for the Storm Damage Repairs on Alisal Road Project. The bids ranged from \$360,476.16 to \$564,950.00 with an average bid amount of \$437,437.95. The Engineer's estimate was \$404,000 which is about 12.1% above the low bid amount. The Department reviewed the bid documents submitted by the lowest bidder, Seamair Construction, Inc., and found their bid to be responsive. In accordance with the Public Contract Code, the award should be made to the lowest responsive bidder.

On February 8, 2024, a significant storm event, down poured throughout the County of Santa Barbara. Alisal Road and the surrounding area experienced intense rainfall. The storm event caused unusually high runoff volumes due to the high precipitation. The increase in stormwater flow exceeded the capacity of the existing 48" CMP culvert and caused it to clog and led to the excess stormwater to overtop onto Alisal Road. This caused localized flooding and created unsafe driving conditions. The event was designated as emergency event "24STM1" and immediate emergency work was required to restore Alisal Road and the natural alignment of Nojoqui Creek.

To prevent or mitigate a future emergency event at Alisal Road, a hydraulic analysis determined that the existing single 48" culvert needs to be replaced with four 48" diameter reinforced concrete pipes to allow the expected stormwater volumes to flow through this area of Nojoqui Creek. Concrete headwalls will be constructed at both the inlet and outlet of the new culvert system, to provide structural support and protect against erosion.

These design improvements will be done by open trench excavation, meaning that Alisal Road will be fully closed during construction. Full closure of the road will allow the construction crew to complete the culvert replacements more efficiently and safely, therefore minimizing the construction duration and long-term disruption to traffic.

Completing new CEQA documentation and obtaining the necessary regulatory permits would likely take approximately five years. Leaving the site in disrepair for that duration would pose significant risks to public health and safety, jeopardized County roadway infrastructure, and threatened the integrity of Nojoqui County Park facilities.

Cal. Code Regs. tit. 14, § 15269(c): "Specific actions necessary to prevent or mitigate an emergency. This does not include long-term projects undertaken for the purpose of preventing or mitigating a situation that has a low probability of occurrence in the short-term, but this exclusion does not apply (i) if the anticipated period of time to conduct an environmental review of such a long-term project would create a risk to public health, safety or welfare, or (ii) if activities (such as fire or catastrophic risk mitigation or modifications to improve facility integrity) are proposed for existing facilities in response to an emergency at a similar existing facility."

Reasons to support exemption findings: Consistent with this exemption, this proposed project involves an activity related to the repair and maintenance activities for an existing road facility near creeks and creek banks. The project allows for a public safety activity designed to maintain a safe working condition of the roadway facilities as they were constructed. Further, there are no unusual circumstances which would create a possibility that there would be a significant effect. Therefore, this project can be found to be categorically exempt from CEQA.

There is no substantial evidence that there are unusual circumstances (including future activities) resulting in (or which might reasonably result in) significant impacts which threaten the environment. The exceptions to the categorical exemptions pursuant to Section 15300.2 of the State CEQA Guidelines are:

(a) Location. Classes 3, 4, 5, 6, and 11 are qualified by consideration of where the project is to be located -- a project that is ordinarily insignificant in its impact on

the environment may in a particularly sensitive environment be significant. Therefore, these classes are considered to apply all instances, except where the project may impact on an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies.

CEQA Guidelines Section 15301 is a Class 1 exemption; therefore, this exception does not apply.

(b) Cumulative Impact. All exemptions for these classes are inapplicable when the cumulative impact of successive projects of the same type in the same place, over time is significant.

The project involves the repair and maintenance to existing facilities to improve public health and safety and prevent or mitigate a future emergency. In addition, there are no other identified projects which would contribute to cumulative impacts. Therefore, this exception does not apply.

(c) Significant Effect. A categorical exemption shall not be used for an activity where there is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

The project involves existing culvert repair and replacement to maintain safe public roadway and to prevent or mitigate a future emergency. The project is planned in two phases and scheduled around both the winter rainy season and the bird nesting season. This approach was developed collaboratively by CDFW, environmental advocates, representatives of the Audubon Society, and County staff. Under the CDFW emergency permit, work was required to begin within one year of the storm event, but project completion was allowed to extend into the second year to minimize environmental impacts during sensitive biological periods (MBTA). The projects will occur during the time of year when there no sensitive resources located at the project sites. Therefore, this exception does not apply.

(d) Scenic Highways. A categorical exemption shall not be used for a project which may result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway. This does not apply to improvements which are required as mitigation by an adopted negative declaration or certified EIR.

The project does not involve a scenic highway or a project which may result in damage to a scenic resource, removal of trees, rock outcropping or similar resource. Therefore, this exception does not apply.

(e) Hazardous Waste Sites. A categorical exemption shall not be used for a project located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code.

There are no hazardous wastes site locations in the roadway right of way. Therefore, this exception does not apply.

(f) Historical Resources. A categorical exemption shall not be used for a project which may cause a substantial adverse change in the significance of a historical resource.

The project site location is not identified as a historical resource. Therefore, this

exception does not apply.
