SUBJECT: **Establish a No Parking Zone on Francine Lane in the Fourth Supervisorial District**

**RECOMMENDATIONS:**

That the Board of Supervisors adopt a resolution establishing a "No Parking" zone on Francine Lane in the Orcutt area.

**ALIGNMENT WITH BOARD STRATEGIC PLAN:**

The recommendation is primarily aligned with Goal #2: Ensure the public health and safety and provide essential infrastructure. (or refer to the Board Letter Procedure Book for more examples of the Strategic Plan Goals).

**EXECUTIVE SUMMARY & DISCUSSION:**

Francine Lane is a 31-foot wide roadway west of Bradley Road with fronting commercial businesses along the north side, and is located in the Orcutt area.

A request was received from the owners of a commercial business being built at the above mentioned location. The request is for a No Parking zone with red curb to be established on the north side of Francine Lane. This No Parking zone will provide adequate sight distance for vehicles exiting the parking lot of the new Church onto Francine Lane. The concern is that drivers leaving the Church cannot see the oncoming traffic in time to provide for a safe entry onto Francine Lane. The Santa Barbara Traffic Section performed a sight distance study at this location and based on results from this study is recommending that a No Parking zone would create a safer environment. Therefore, the Public Works Traffic Section has been asked to prepare the attached resolution establishing a No Parking zone at the following location:

- On the North side of Francine Lane from a point 69 feet west of the centerline of Bradley Road to a point 240 feet west of the centerline of Bradley Road.
