Summary Text:

Notice of Completion will provide for release of retention to the contractor for the recently replaced boilers in the Santa Barbara main jail.

Background:

The County of Santa Barbara entered into a contract (BC-07-058) with MM Mechanical on September 12, 2006 to replace the 35 year old boilers at the main Jail that had deteriorated beyond what was economically feasible to continue to repair. The new boilers will ensure a source of hot water for heating and bathing accordance with Title 24 section 470A.3.4 and Title 15 section 1266 of the California Code of regulations.

The work was completed sufficiently by December of 2006 to allow use of the new boilers. However, the time needed to complete final submittals and drawings delayed formal completion until March of 2007.

On September 12, 2006 your Board approved the construction agreement for the subject project with MM Mechanical in the amount of \$329,857.00 for all work called for in the construction documents.
