Review and approve the Statement of Final Quantities for work performed and materials supplied for this project by the Contractor, Union Asphalt, Inc. (A Local Vendor), P. O. Box 1280, Santa Maria, California 93456, in the amount of \$1,634,004.21

## **Summary Text:**

Construction of this project took place in the unincorporated areas of Lompoc, Los Olivos, Mission Hills, Orcutt, Santa Maria, Guadalupe and Cuyama in Santa Barbara County. Jupiter Avenue in Vandenberg Village was added to the project due to road damage caused by heavy equipment used during construction of the Providence Landing residential development by Capital Pacific Homes. (The developer reimbursed the County for this portion of the project.) Approximately 13 lane miles of roads were resurfaced with the completion of this project. Construction consisted of repairing failed pavement areas and placement of a Type B asphalt concrete overlay over a pavement reinforcing fabric and asphalt concrete leveling course.

The Director of Public Works accepted this project as complete on August 31, 2007. The project was completed on time and on budget.

# Background:

The Proposition 42 funded locations were approved by your Board on September 26, 2006 and are a part of the AB 2928 fund, which later became voter approved Proposition 42 signed by the Governor in 2001. The Measure 'D' funded project locations were approved by your Board in the FY 2006/07 Road Maintenance Annual Plan (RdMap) on March 28, 2006.
