- A. Approve plans and specifications for Construction of County Wide 2003/2004 Measure 'D' Miscellaneous Concrete Repair, Tree Root Pruning and Shielding in Santa Barbara County, County Project No. 820500;
- B. Award the construction contract in the amount of \$ 669,289.40 to the lowest responsible bidder, Mendez Concrete, Inc. (Not A Local Vendor), 1210 E. Santa Paula Street, Santa Paula, California 93060, subject to the provision of documents and certifications, as set forth in the plans and specifications applicable to the project and as required by law;
- C. Authorize the chair to execute the construction contract upon return of the Contractor's executed contract documents, and the review and approval of the County Counsel, Auditor-Controller and Risk Manager or their authorized representatives:
- D. Approve a contingency fund in the amount of \$ 45,964.47 for Construction of County Wide 2003/2004 Measure 'D' Miscellaneous Concrete Repair, Tree Root Pruning and Shielding in Santa Barbara County, County Project No. 820500.

Alignment with Board Strategic Plan:

The recommendation(s) are primarily aligned with Goal No. 1, An Efficient Government Able to Respond Effectively to the Needs of the Community.

Executive Summary and Discussion:

On Thursday, August 7, 2003, two (2) bids were opened for the Construction of County Wide 2003/2004 Measure 'D' Miscellaneous Concrete Repair, Tree Root Pruning and Shielding in Santa Barbara County, County Project No. 820500. Mendez Concrete, Inc., a California Corporation, submitted the lowest responsible bid in the amount of \$ 669,289.40, which was 4% above the Engineer's Estimate. Staff has performed an analysis of the bids received and has determined that the low bid is responsive and responsible. Staff recommends awarding this contract to Mendez Concrete, Inc.



The project is one of the strategies the Department employs in its annual Preventive Maintenance Program and consists of the repair of the existing hardscape by the removal and replacement of damaged concrete curbs, gutters and sidewalks, installation of federally mandated curb ramps, tree root pruning and shielding. Approximately 3,534 linear feet of sidewalk and 3,437 linear feet of curb and gutter will be repaired with the construction of this project.

Your Board approved the project as part of the FY 2003/2004 Capital Improvement Plan. The specific project locations were approved by your Board in the FY 2003/2004 Road Maintenance Annual Plan (RdMap) and are attached for your information.
