

# AGREEMENT FOR SERVICES OF INDEPENDENT CONTRACTOR

between  
County of Santa Barbara  
and  
Good Samaritan Shelter

## FIRST AMENDMENT

This is the First Amendment (hereafter referred to as "First Amendment") to the Agreement for Treatment Services, number **BC 19-233** (hereafter Agreement), by and between the County of Santa Barbara (County) and Good Samaritan Shelter (Contractor), for the provision of enhanced treatment services to County of Santa Barbara Probation clients.

**WHEREAS**, the Agreement is effective through the end of June 30, 2020;

**WHEREAS**, County and Contractor desire to amend the Agreement to add a one (1) full time (FTE) Drug and Alcohol Certified Counselor which will be allocated half time (.5) to Section 1.C.1 of the Agreement, and half time (.5) to Section VIII.C.1 of the Agreement to support the treatment programs; and

**WHEREAS**, the addition of a one (1) full time (FTE) Drug and Alcohol Certified Counselor to the Agreement will increase the total cost of the Agreement to \$519,130; and

**WHEREAS**, this First Amendment incorporates the terms and conditions set forth in the Agreement approved by the County of Santa Barbara on June 4, 2019, BC 19-233;

**NOW, THEREFORE**, the Agreement is amended as follows:

In Exhibit A, Statement of Work, Section I. C. 1. and Section VIII. C. 1. is amended as follows:

I.C.1.: One (1.00) Full Time Equivalent (FTE), and one (.5) Half Time Equivalent Drug and Alcohol Certified Counselor.

VIII.C.1: One 15 hours per week and one (.5) Half Time Equivalent Drug and Alcohol Certified Counselors.

In Exhibit A, Statement of Work, Section I. B.1. and Section VIII. B.1. adding an additional group session of 90 minutes per week to each section as follows:

I.B.1.: CONTRACTOR shall provide three (3) 90-minute meetings per week to six (6) groups of up to twelve (12) clients per group. The group will focus on MRT and Seeking Safety in accordance with training and model requirements. This substance abuse treatment will include the use of the relapse prevention workbook and lessons. When there

are three (3) or more female clients, there will be one (1) female only group. The group times will be determined by COUNTY.

VIII.B.1.: CONTRACTOR shall provide three (3), 90-minute meetings per week to three (3) groups of up to twelve (12) clients per group. The group will focus on MRT in accordance with the MRT training and model requirements. This substance abuse treatment will include the use of the relapse prevention workbook and lessons. The group times will be determined by COUNTY and will be staffed by a Drug and Alcohol Certified Counselor who is MRT trained and certified.

1. In Exhibit B, Payment Arrangements, A, **replace** as follows:

A. For CONTRACTOR services to be rendered under this Agreement, CONTRACTOR shall be paid a total contract amount, including cost reimbursements, not to exceed, **\$519,130**.

2. Delete Attachment B-1, Schedule of Fees, and replace with **AMENDED Attachment B-1, Schedule of Fees** as follows:
